
HOME PAGE FEATURES

- The Order List can be filtered by 30,60, and 90 days, or All orders





SHIPPING FAVORITES

The Shipping Favorites feature allows you to save a Ship-To address for use in future orders.

To add a favorite, check the **Add this to my favorites.**. box and provide a name. If the name you enter already exists, the existing favorite is overwritten



SHIPPING METHOD

You will be required to specify a shipping method for all orders

UPS Standard shipping is provided at no charge

UPS Next Day requires authorization. Selecting this option sends an automated authorization request to a valid authority for approval or denial. If your request is denied, the shipping method defaults back to UPS Standard shipping automatically

Do Not Ship Before allows you to place order far in advance of when the order needs to actually ship. This is great for trade show orders

The **Custom Shipper** option allows you to select from a large list of alternate carriers that you may use *if* you have an account with them.

Brokers who want to ship other than Standard will have to choose Custom Shipper and provide an account number.
